Apple Health

EVALUATIONS & TREATMENT

Seattle Children's Hospital

Diagnostic evaluations and shortterm mental health treatment for children and teens up to age 18. A full diagnostic evaluation (two or three visits) can clarify why a child is having emotional and behavioral problems and how a mental health or medical professional can help.
