

Due to his high level of care needs, he has also resided in a residential program in the State of Washington since he was 10 years old. He is now 20 years old, and his needs are increasing as he moves into adulthood.

I am a Medicaid recipient and it covers part of my medical needs that are not covered by Medicare.





The picture you see is my daughter sitting in a van watching kites being flown on a beautiful beach along the Salish Coast.

My daughter is highly impacted by autism, is nonverbal and has high behavior support needs. She lives in a supported-living home with 3 roommates who also have disabilities qualifies for 24-hour, 7 days a week care authorized through the Developmental Disabilities Administration funded by federal Medicaid and an equal match of State-funded Medicaid to pay her care workers to support her to live in her community. Cutting Medicaid will cause job loss and poverty to her amazing care workers. Cutting Medicaid will be life-threatening to my daughter. My story is about 1 house in one town in one county in one state. This scenario will be repeated by the millions in each town, each county, in each state.
